

SUPPLEMENTARY REGULATIONS 2024 AMA SPEEDWAY NATIONAL UNDER 21 CHAMPIONSHIP

Kevin Harvick's Kern Raceway, Bakersfield, CA November 2, 2024

Name of Event: 2024 AMA Speedway National Under 21 Championship,

Sanction: The series is sanctioned by the American Motorcyclist Association

Rules and governance: 2024 AMA Racing Rulebook and these Supplementary Regulations govern the competition. The AMA reserves the right to modify and reissue these Supplementary Regulations as necessary.

Purse: \$2,220 (final amount may increase)

Officials: Each event will be run according to the 2024 AMA Racing rulebook and these Supplemental Regulations. The overall running of the meeting and decisions regarding such matters as postponement, or any matter not covered in writing will be decided on the day between the event advisory group consisting of the promoter or his named clerk of the course, AMA representative and referee. The Event Referee is the sole person responsible for receiving and deciding on all protests.

Clerk of the Course: Steve Evans AMA Representative: Paul Flanders Technical Inspector: Tony Rutledge **Publicity**: All riders will be provided with official AMA decals that must be displayed on their helmet and motorcycle beginning with the rider parade and throughout the program, including victory podium celebration.

Fork Covers: Riders retain exclusive right to advertising on their machines, including the fork covers.

Fuel: Fuel is provided

Tires: Any approved speedway tire in 2024 AMA rulebook or subsequent technical issues is allowed

Substance Abuse Policy: Compliance with the AMA's Substance Abuse Policy is an essential precondition to competition. Random tests for prohibited substances may be conducted at the discretion of AMA Racing.

Entered Riders – Starting positions and draw conducted by AMA Track Racing Manager or delegated personnel.

Eligibility – Per FIM regulations the minimum age of participant is 16 years old. Exception: A rider under 16 years old who has written authorization approved by AMA Senior Speedway Referee and AMA Track Racing Manager or his delegated representative. Maximum age eligibility is any rider who was 20 years old on January 1 2024.

In the Qualification Heats, riders take the starting gate positions indicated. For the Semi-Finals the highest scorer has first choice of gate position, the second-highest scorer has second choice, and so on.... Gate A is on the inside of the track, whilst Gate D is on the outside.

For the final, the semi final winner with the highest heat points gets first choice. Semi final winner with lower points second gate choice, Semifinal second place higher heat points third choice and semi final second place low points last choice.

Final classification of top 4 positions is on Main event.

5th 3rd place in semifinals with higher heat points

6th 3rd place in semi final with lower heat points

7th place 4th in semifinals with higher heat points

8th place 4th place in semifinals with lower heat points.

9th-13th based on heat race points.

Where two or more riders are tied on race points after the Qualification Heats or Semi-Finals, the tie is resolved as follows:

- 1. When only two riders tied, points scored in the heats where they met. If they meet twice, then most recent meeting breaks the tie.
- 2. Most wins
- 3. Most second places
- 4. Most third places
- 5. Most fourth-place finishes
- 6. Least DNF
- 7. Ballot if not deciding 8th place and down
- 8. Run Off if needed to determine 8th place and down semifinal spot.

SUPPLEMENTARY REFEREE RULES FOR RESTARTS AND EXCLUSIONS

Unsatisfactory Starts: In the event the referee determines that an unsatisfactory start has occurred, and the race is red flagged, the rider considered at fault will be provided with a warning for the first offense. The warning will be recorded by the referee. If the rider commits any further unsatisfactory starts during the remaining meeting the rider will be excluded from that race for each occurrence.

Race Completion: Each race must complete 4 laps. In the event a race is stopped before the completion of 4 laps the race will be restarted. The race will be considered complete if the leader crosses the finish line on the 4th lap regardless of if the checkered flag is waved.

Back Straightaway Track Perimeter Marker: There will be a chalk line in the back straight to define where the racing track ends. If during the first lap of the race multiple riders make contact and a rider is forced out of bounds the race can be stopped at the referee's discretion and considered first turn bunching. The race will be subsequently restarted. There will not be exclusions for crossing the line, but the chalk line delineates where the speedway surface ends, and the car track begins and is primarily done for safety.

Race Stoppages: If a race is stopped during the first turn because of contact between riders, or the out of bounds condition listed above, at the referee's discretion all 4 riders may be included in the restart. If the referee clearly determines fault, the offending rider may be excluded. If a race is stopped because of a red flag after the first turn the referee will determine who was the primary cause of the stoppage and exclude that rider from restart of that race.

The role of AMA representative is to observe and see that all AMA rules and supplementary regulations for the meeting are being followed and to assist race day personnel when requested with procedures and rules interpretation. The AMA representative's responsibility is to report any rules violations to the meeting referee. The AMA representative has no authority to overrule the meeting referee.

Note these rules SUPPLEMENT the current 2024 AMA Rulebook. All riders are encouraged to review both the above and the full rulebook on a regular basis. The referee will make the best decision based on the rulebook. The referee's decisions regarding on track races, results and reruns are final and cannot be overturned by promoter, AMA Rep or any other personnel.
